Terms of Use

- 1. If you are subscribed to a premium membership, your coach will be assigned according to the availability of our instructors and the operation of the tunnel.
- 2. Flight time cannot be used to coach a third party.
- 3. Flight time cannot be resold.
- 4. If you leave the Membership and have remaining time in your account, the tunnel time will not be refunded under any circumstances and must be used within the validity period, which is 6 months from the date of purchase.
- 5. The Membership commitment is a minimum of 6 months. To terminate your subscription, you must notify us in writing 30 days before the automatic renewal.
- 6. Any subscription that has started must be paid.
- 7. Windoor reserves the right to accept or reject a member.
- 8. In the event of non-compliance with the terms of use, WINDOOR reserves the right to terminate a member's subscription without compensation.
- 9. The contract is valid from its signing and is valid for a duration of 6 months, with automatic prolongation for another 6 months.
- 10. The time can be shared with other members of the membership.
- 11. The subscription is non-transferable.
- 12. Tunnel time cannot be transferred to a third party.
- 13. Tunnel time is automatically credited to the customer's account every month (on the effective date of the contract).
- 14. A monthly invoice is available in the online customer account. Payment must be made no later than 10 days after receiving the invoice (bank transfer, cash, or online payment). Failure to pay may result in the suspension of the subscription and flight time.
- 15. Tunnel time can be accumulated for up to 6 consecutive months. Tunnel time will cease to be credited and will be considered lost if the accumulation limit is reached.
- 16. Coaching is included in the premium membership subscriptions price.
- 17. The subscription holder can purchase additional flight time and coaching according to the current rate of their subscription.
- 18. The subscription holder can cancel flight time bookings with 48 hours notice.
- 19. Upgrading a membership subscription is possible.
